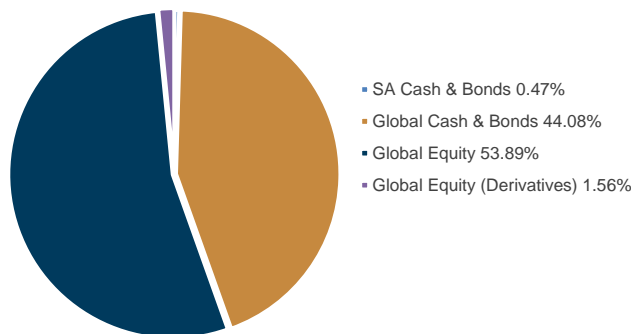

FUND MANAGER'S COMMENTARY

International:

Markets gave investors a reality check in the third quarter after a strong start in the first half of 2023.

Developed market equities, as proxied by the MSCI World Index, fell 3.4% over the quarter reducing the year-to-date returns to 11.6%. A sell-off in global bond markets were mostly to blame for the pressure on risk assets, with the global aggregate bond benchmark falling by 3.6% in the third quarter, after dropping 2.9% in September alone.

Chairman of the US Federal Reserve, Jerome Powell, made it clear at the September FOMC meeting that interest rates in the US will remain at higher levels for longer than expected. This led to a large spike in the yield of the 10-year US Treasury bonds from 4.09% to 4.57%, the highest rate since October 2007.

Renewed concerns about the state of the Chinese property sector weighed on emerging markets. Investor sentiment turned negative despite several new stimulus measures announced during the quarter by the Chinese government aimed at stabilising housing activity.

Tight oil markets pose further headwinds to the global economy and the inflation outlook. Saudi Arabia and Russia indicated extend voluntary oil output cuts for the rest of the year. The price for Brent crude oil jumping 27% over the quarter.

Local:

SA's headline year-on-year inflation rate for August came in slightly higher than expected at 4.8%, well within the South African Reserve Bank's (SARB) 3% to 6% target range. The inflation rate is likely to accelerate over the next two months due to a weaker rand and recent fuel and energy price increases. The SARB cautioned that risks to rising inflation remaining firmly to the upside and highlighted the importance of anchoring expectations at the mid-point of the target range. The likelihood of further interest rate hikes looks slim, though not impossible.

The rand ended the month and the quarter relatively unchanged at R18.93 to the US dollar. The minor change hides the volatility experienced over the period as the rand traded as strong as R17.42 in July and as weak as R19.33 during September. Nominal bond yields closed the month higher, with the yield of the 10-year government bond rising from 11.71% to 12.37%, leading to a negative return of 2.3% for the FTSE/JSE All Bond Index.

Local equity markets continued to weaken as the FTSE/JSE All Share Index dropped 2.5% during September, led mostly by declines in the financial and industrial sectors.

The Kruger Ci Funds continued to hold up well and delivered the following returns during September 2023: The Kruger Ci Prudential Fund (-1.4%); the Kruger Ci Balanced Fund (-1.6%); the Kruger Ci Equity Fund (-1.6%), the Kruger Ci International Flexible Feeder Fund (-3.4%) and the Kruger Ci International Equity Feeder Fund (-4.1%).

The annual fees include a fee of up to 0.20% (Class A) or 0.30% (Class G) payable to Ci Collective Investments. These fees are stated exclusive of VAT. Please note that in most cases where the financial services provider (FSP) is a related party to the fund manager, the FSP/distributor may earn additional fees other than those charged by the fund manager. A FX fee of up to 0.05% (incl. VAT) on any FX transactions may be payable to Kruger International. Kruger International Mauritius (KIM) is the investment advisor on the International Flexible Fund. The fund will invest in the International Flexible Fund. KIM and SIP may earn an annual investment advisory fee of up to 1.00% on this investment. Kruger International does not charge an annual management fee against the value of investments that are placed in the International Flexible Fund.

Characteristics

This is a global multi-asset flexible equity fund which means that the fund may have a maximum equity exposure of up to 100% at all times. This fund is a feeder fund which means that it may only invest in a single unit trust, exchange rate swaps and assets in liquid form. A feeder fund is a fund that invests in a single fund of a collective investment scheme, which levies its own charges, which could result in a higher fee structure for the feeder fund.

Risk Reward Profile: High

Typically, the lower the risk, the lower the potential return and the higher the risk, the higher the potential return. There is no guarantee that returns will be higher when investing in a fund with a higher risk profile. The risk profile for this fund is rated as high, as it may invest up to 100% in equity securities, both locally and abroad. The risk refers only to volatility.

RISK DEFINITIONS

Market Risk

Equity markets are volatile and the price of equities fluctuate based on a number of factors such as changes in the economic climate, general movements in interest rates and the political and social environment which will also affect the value of the securities held in the unit trust, thereby affecting the overall value of the unit trust.

Currency Risk / Foreign Exchange Risk

This risk is associated with investments that are denominated in foreign currencies. When the foreign currencies fluctuate against the South African Rand, the investments face currency gains or losses.

Concentration Risk

Unit Trusts pool the assets of many investors and use the proceeds to buy a portfolio of securities. There are regulations in place which limit the amount that a unit trust may invest in securities, thereby spreading the risk across securities, asset classes and companies.

Liquidity Risk

This relates to the ability of the unit trust to trade out of a security held in the fund at or near to its fair value. This may impact on liquidity and in the case of foreign securities, the repatriation of funds.

Credit Risk

Credit risk arises where an issuer of a non-equity security or a swap is unable to make interest payments or repay capital, which could result in losses to the fund.

Total Return Swaps Risk

The fund may invest in total return swaps. Total return swaps are unlisted instruments issued by a bank to provide the return of a specific index. The value of the instrument is directly linked to the performance of the underlying equities in the index and will fluctuate in line with daily market movements. Some of the equity exposure in the fund could be derived through total return swaps instead of physically holding the underlying equities.

Inflation Risk

The risk of potential loss in the purchasing power of your investment due to a general increase of consumer prices.

Political Risk

The risk that investment returns could suffer as a result of a country's political changes or instability in the country. Instability could come from changes in the country's government, policy makers or military.

Tax Risk

This risk relates to any change to tax laws or to the interpretation of existing tax laws which has an impact on the manner in which unit trusts are taxed.

Compliance Risk

This refers to the risk of not complying with the legislation, regulations, prescribed investment limits and internal policies and procedures by the manager or the fund manager.

Total Expense Ratio (TER): The above TER % has been annualised and indicates the percentage of the value of the fund which was incurred as expenses relating to the administration of the fund over the rolling 3 year period or since fund inception, on an annualised basis. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER's cannot be regarded as an indication of future TER's. Transaction Cost (TC): The above TC % has been annualised and indicates the percentage of the value of the fund which was incurred as costs relating to the buying and selling of the assets underlying the fund. Transaction Costs are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, investment decisions of the investment manager and the TER. Total Investment Charge is the TER plus TC which indicates the percentage of the value of the fund which was incurred as costs relating to the investment of the fund. Calculations are based on actual data where possible and best estimates where actual data is not available. Performance quoted is for lump sum investment with income distributions, prior to deduction of applicable taxes, included. NAV to NAV figures have been used and is quoted net of all fees. The annualised return is the return of the performance period re-scaled to a period of one year. Performance is calculated for the fund and individual investor performance may differ as a result of initial fees, actual investment date, date of reinvestment and dividend withholding tax.
